OFFICE MEMORANDUM

Subject: Committee on Operationalization of AYUSH Department in each new AIIMS

1. In pursuance to the instructions of Hon'ble Health & Family Welfare Minister at AIIMS Patna on 21 June 2014, and in the light para 2.9 of Circular instructions, circulated vide F.No.28016/2/2013-SSH and CIRCULAR No. PMSSY-01-July-2014 Dtd. 3 July 2014, which *inter alia*, states, "**Department of AYUSH must have a pride of place in every new AIIMS. There should be focus on integrated medicine and related technology. Indigenous systems of medicine should not be ignored,**" the Competent Authority in the Ministry of Health & Family Welfare have approved constitution of the following **Committee of Directors** to recommend a blue print for operationalization of AYUSH Department including Yoga Training & Therapy Centre at each new AIIMS:

2. **Terms of Reference** of the Committee are as follows:

- i. To take into account the experience of Institutions of National Importance (INI) on their existing AYUSH set up.
- ii. To recommend an action plan for setting up of Department of AYUSH with 30 bed IPD facility at each of six new AIIMS.
- iii. To recommend guidelines for setting up different training and therapy centres in the Deptt of AYUSH of six new AIIMS.
- iv. To frame cost estimates (not civil construction because it is included in the original work packages) for setting up the Department of AYUSH.

3. The Committee will submit its recommendations to MoHFW within a period of three weeks considering the timeline of December 20, 2014 given for operationalization of the six new AIIMS. The Committee may co-opt any other person/organization as Member depending upon requirement. Expenditure on functioning of the Committee shall be met out of Grant in Aid available with AIIMS, Patna, with the concurrence of FA, AIIMS, Patna.

4. **The first meeting of the Committee will be held in Conference Room No 155-A, 1st floor, Nirman Bhavan at 2.30 PM on 04 August 2014.**
