**Subject: Local purchase of pre-clinical equipments.**

Sir,

I am directed to refer to this Ministry's Order of even no. dated 19<sup>th</sup> December, 2012 regarding procurement of pre-clinical equipments for six new AIIMS through Procurement Support Agent (PSA) and to say that for completion of the process of assessment of requirements and specifications of equipments, as outlined in the order, coordinated exercise with the Requirements and Specifications Committee (RSC) was carried out by PSA. Based on this exercise with RSC which also included Directors of new AIIMS, finalized the specifications as well as lists of equipments in respect of Bio-chemistry, Anatomy, Physiology and Community Medicine.

2. On the basis of the above mentioned exercise and the recommendations of Technical Committee, the PSA has communicated to this Ministry the lists of equipments alongwith quality and approximate cost. PSA has communicated the view of the RSC that different items need to be procured through local purchase mechanism, which are to be as per provisions of General Financial Rules (GFR). Departmentwise details of such items alongwith estimated unit price and quantity are given in the lists at Annexures I to IV.

3. The matter has been examined in this Division in consultation with IFD and it has been decided that procurement of equipments indicated in the Annexures should be made by the respective new AIIMS institutions in strict compliance with provisions contained in the GFR, procurement manual and other instructions of the Ministry of Finance (which can be downloaded from Ministry of Finance website for easy reference) and Financial & Administrative powers delegated to the Institutes by this Ministry through different Gazette notifications. For any clarification regarding specifications, source of supply (Vendor), prices, etc., PSA may be approached.



4. It is reiterated that it will be the sole responsibility of the Institute to ensure adherence with all relevant rules and instructions prescribed by the Government for procurement/purchases. Ministry may be kept informed of the procurement status from time to time.

5. This issues with concurrence of IFD vide Diary No. C-6 dated 02.04.2013 and with the approval of Secretary, HFW.
