MINUTES OF MEETING REGARDING GAP ANALYSIS OF GOVERNMENT MEDICAL COLLEGE, BHAVNAGAR & GOVERNMENT MEDICAL COLLEGE, SURAT FOR UPGRADATION UNDER PHASE-IV HELD ON 18<sup>th</sup> MARCH, 2017 AT 12:00 NOON IN AIIMS, JODHPUR

A meeting, convened with advance notice, on Gap Analysis under Phase-IV of Pradhan Mantri Swasthya Suraksha Yojana up-gradation, submitted by State Government in respect of Government Medical College, Bhavnagar & Government Medical College, Surat, was held in AIIMS, Jodhpur on 18<sup>th</sup> March, 2017 at 12:00 Noon. The meeting was chaired by Joint Secretary, PMSSY and Director, AIIMS- Jodhpur. The Participants list is at Annex-A.

- 2. Joint Secretary, PMSSY welcomed the participants and recapitulated the process involved in up-gradation programme under Phase-IV of PMSSY. Director (PMSSY) spoke about the time lines (of October, 2018 for completion of project on ground) given by higher authorities for time bound execution of the projects in a cost-effective, environment friendly, transparent, equitable and statutory/regulatory compliant manner.
- 3. Joint Secretary, Medical Education, Gujarat ensured that the encumbrance free land for the construction of Super Speciality Block will be provided at both the sites so that there is no delay in the project.
- 4. In case of Government Medical College, Surat, State Government informed that for kidney transplantation, State Government was making G+ 7 structure. Of which, 3 floors and RCC structure for entire building is ready. Representative of State Government & GMC, Surat requested that the Super speciality block shall be planned and executed in this building by completing the remaining floors. State Govt. also requested that as first three floors and RCC structure for entire block has been executed by the State Govt. Project implementing unit, the balance civil work may also be entrusted to the same agency. It was decided that a technical committee comprising of SE, AIIMS-Jodhpur, EE, AIIMS-Jodhpur and Senior Architect from the Ministry, shall visit the site to examine the feasibility of proposal before its further processing.

The agreed position arrived at, in respect of Government Medical College, Bhavnagar 5. and Government Medical College, Surat is summarized as follows:
