**CIRCULAR NO.11 PMSSY- of 2014**

**Sub: Filling up of Group 'B' & 'C' posts, methodology and composition of Selection Committees.**

The Ministry has been receiving references from the new AIIMS regarding methodology and composition of Selection Committees for Group 'B' and 'C' posts. The matter has been examined in the Ministry. Earlier, the process/methodology regarding receipt of application, advertisement, etc., conveyed vide Ministry's communication No.Z-28016/69/2013-SSH dated 4<sup>th</sup> April, 2013 read with No.A-11013/01/2010-SSH dated 6<sup>th</sup> August, 2013, and also as ratified by Institute Bodies of each new AIIMS in their 1<sup>st</sup> meetings held in October, 2013 for selection and filling up the said posts, was detailed. Despite, clear instructions provided on these aspects, Ministry is receiving references from various new AIIMS to clarify about the methodology and composition of selection committees, which lead to unnecessary delay in finalizing the appointment to such posts.


2. Vide Ministry's communication No.A-11013/01/2010-SSH dated 6<sup>th</sup> August, 2013, it was conveyed to AIIMS Patna that Institute Body for each new AIIMS has been formed. Framing of Rules and Regulations for each new AIIMS would be as provided under the AIIMS Act 1956 and AIIMS (Amendment) Act 2012. Till such time Rules and Regulations are framed for each new AIIMS, Rules and Regulations of AIIMS New Delhi would apply as already approved and communicated. Later as IB of the Institute held in its 1<sup>st</sup> meeting in October, 2013 has ratified the said process and methodology, the composition of ad-hoc selection committees has attained the finality & become the regular composition of Selection Committees

In view of above, it is reiterated and clarified that methodology/composition of Selection Committee as provided by the Ministry's guidelines No.Z-28016/69/2013-SSH dated
