Several references have been received from new AIIMS requesting this Ministry to consider delegation of financial powers to the Directors of six new AIIMS at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur and Rishikesh upto Rs.5.00 crore from the existing delegated powers of Rs.2.00 crore in respect of infrastructure works, procurement of equipment and furniture etc.


2. The matter has been examined in this Ministry in consultation with Integrated Finance Division, MoHFW. The financial powers delegated to Directors of six new AIIMS vide this Ministry's circular No. PMSSY-04-July, 2014 (No.Z-28016/37/2014-SSH) dated 24.07.2014 is further revised as under:

Nature of Powers	Director (or SE as the case may be)	Director (or SE as the case may be)
	Existing	Revised
To incur expenditure on procurement of Institute equipment and infrastructure works within the allocated budget.	Full power up to Rupees two crore subject to condition that SE AIIMS would exercise power of SE as per CPWD manual.	Full power up to Rupees 05 (five) crore subject to condition that SE AIIMS would exercise power of SE as per CPWD manual.

3. The above revised delegation of financial powers to Directors of six new AIIMS is subject to adoption of GFRs, manual of procurement norms, fiscal orders, general and economy instructions issued by Ministry of Finance from time to time and availability of funds.

4. This issues with the approval of Hon'ble HFM, being President of the Institute i.e. new AIIMS.
