- To keep in mind the quality benchmark of equipments vis-a-vis expenditure of the public iii. money and sustainability.
- The Committee will take into account different brochures, draft specifications etc. so that multivendor and genuine manufacturer participation or sole authorized vendor situation is aimed at in a transparent manner.
- Committee will document its proceedings, duly minuted and supply the same to MoHFW along with its recommendation.
- Responsibility of facilitating, the fixing and convening of the meetings, issuing agenda for meeting, maintaining back ground papers and preparing minutes and taking necessary follow up action etc. would be performed by HLL.
- The Committee is requested to submit its recommendation within 2 weeks from the date of VII. issue of this order.
