Application from eligible candidates are invited in the prescribed proforma for appointment on deputation basis to the post of Financial Advisor at AIIMS Raipur. The last date for receipt of application is within 45 days from the date of publication of the advertisement in the Employment News.

III. Period of Deputation, including period of deputation in another cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years. However, further extension beyond 3 years, up to maximum 7 years may be considered in administrative exigencies.

IV. Upper age limit: The maximum age limit for appointment by deputation shall be not exceeding 56 years on the closing date of receipt of applications.
