CIRCULAR NO. PMSSY-04- JULY 2014

**Subject: Delegation of Financial and Administrative Power to the Directors of six new AIIMS set up at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur and Rishikesh.**

In pursuance of the deliberations by the Union Health and Family Welfare Minister (President, AIIMS) with the Directors of six new AIIMS held at Nirman Bhawan, New Delhi on 30 May 2014 and, after due examination of the need for further enhancement in already delegated financial and administrative powers to the Directors (or SEs as applicable), the following further delegation in financial and administrative powers, compared to those notified vide GSR 654 (E) Dtd 28 August 2012 read with subsequent confirmation of the delegation by the Institute Bodies of the respective six new AIIMS made in their first meetings held in October 2013, is hereby made with immediate effect and until further orders or ratification by IB / GB of respective six new AIIMS whichever is earlier:
