The proposal of M/o Health & Family Welfare for creation of 3845 Senior Residents [Level 11] and 4041 Junior Residents [Level 10] for the 960 bedded AIIMS at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur, Rishikesh, Mangalagiri, Nagpur and Kalyani as well as for 750 bedded AIIMS at Gorakhpur, Bathinda, Guwahati, Bilaspur, Deoghar, Bibinagar, Rajkot and Vijaypur (Samba, Jammu) [an Autonomous Institute under M/o Health & Family Welfare] has been examined in this Department and agreed to the creation of following 1304 posts [632 Senior Residents + 672 Junior Residents]:
